

### **RESOLUTION N° 002**

October 15, 2020

By means of which Articles 5° and 8° of Resolution N° 01 of August 17, 2020 are modified, which regulates the **PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP** 2020 to be held in the city of Guayaquil, Ecuador, from January 25 to February 7, 2021.

The President of the **World Skate America**, in use of his legal attributions, statutory and;

#### **CONSIDERING**

- That the Pan American Calendar 2020 foresees the realization of the **PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP**, in the city of Guayaquil, Ecuador, from January 25 to February 7, 2021
- That by means of the Resolution  $N^{\circ}$  01 of August 17, 2020 the mentioned event was convened and regulated.
- That this event will be a qualifying event for the Pan American Junior Games Cali Valle 2021 in the Free Modality.
- That it is necessary to increase the number of athletes in the Senior Category Free Modality for said event.

#### **RESOLVES:**

**ARTICLE 1°** Modify article 5° of Resolution N° 01 of August 17, 2020, which will remain as follows:

#### **ARTICLE 5° LIMIT OF REGISTRATIONS**

- Clubs Event: Each club may register up to five (5) athletes per category, modality and gender.
- Nations event: Each Federation may register up to five (5) athletes per category, modality and gender.
- Coaches: For the club event, each club will have the right to register up to three (3) coaches plus one (1) delegate. For the nations event, each Federation may register up to five (5) coaches and two (2) delegates.

**PARAGRAPH 1º** In the Senior Category, each National Federation may register five (5) skaters of which may register up to three (3) under 23 athletes, as candidates for the only quota each country is entitled to, in order to qualify for the Pan American Junior Games Cali 2021, in the Free Modality.

**ARTICLE 2°** Modify article 8 of Resolution N° 01 of August 17, 2020, which will remain as follows:

## **ARTICLE 8° QUALIFYING PROCESS**

This event will be a qualifying event for the Pan American Junior Games Cali 2021, in the Free Modality granting seven 7 places in each genre. As Colombia is the host country of this competition, it has a fixed quota in both genres, but it must participate in the qualifying event with the athletes that will represent it.

It will qualify based on the results of the Senior Category for those under 23 athletes who manage to be in the first seven (7) places of the Free Modality ranking.

**PARAGRAPH 1°** each country may obtain a maximum quota per gender and their qualifying will be nominal.

**PARAGRAPH 2°** the minimum age of the athletes who achieve their qualifying is a minimum of 12 years and a maximum of 22 years as of December 31, 2021.

**PARAGRAPH 3°** When an CON does not confirm the acceptance of the quota of the qualified skater, the World Skate America will reassign this place to the next best positioned athlete, who was not qualified, may be from the same country or correspond to an athlete from another country.

**PARAGRAPH 4°** Considering that the ages allowed in this qualifying group for the Pan American Junior Games Cali 2021, in the Free Modality, are of various categories and will compete in the Senior Category, the skaters once this qualifying phase is over will be able to return to their original category according to their age in the following international events



# ARTICLE 3° - VALIDITY This resolution shall be valid from the date of its issue.
