

By means of which the PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2020 is summoned and regulated, to be held in the city of Guayaquil, Ecuador, from January 25 to February 7, 2021.

The President of the World Skate America, in use of his legal attributions, statutory and;

CONSIDERING

- That World Skate America extended the programming of the continental calendar 2020 until the end of February 2021
- That the Pan American Calendar 2020 foresees the realization of the PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2020, in the city of Guayaquil, Ecuador, from January 25 to February 7, 2021
- That it is the duty of World Skate America to regulate all the events of the official calendar of all the disciplines of skating.
- That this event will be a qualifier for the Pan American Junior Games Cali Valle 2021 which will
 have the women's and men's free events and a quota of eight (8) athletes in each event
 (Colombia, as host, has a fixed quota).

RESOLVES:

ARTICLE 1º - ANNOUNCEMENT

Convene and regulate, as it is indeed done, the **PAN-AMERICAN ARTISTIC ROLLER SKATING OF CLUBS AND NATIONS CHAMPIONSHIP.**

PARAGRAPH 1º LEVELS AND CATEGORIES

- Championship of clubs, promotional level, tots, mini, espoir, cadets, youth, junior and senior categories.
- Championship of nations, international level, tots, mini, espoir, cadets, youth, junior and senior categories.

In both events, the competition will be held according to the technical regulations set in the World Skate America Artistic 2021 regulations, currently published on the website.

PARAGRAPH 2° No athlete may enter two different categories in the same event. At the promotional level, an athlete can register at different levels (basic, intermediate, advanced) in different disciplines (e.g. Figures cadets basic, free cadets advanced).



PARAGRAPH 3° Athletes who participated in world championships in one category, cannot participate in a minor category in the Pan-American.

ARTICLE 2° DATES Approximate

dates:

- Clubs' Championship: January 25th to 29th, 2021.
- Show and Precision Championship: January 30th, 2021.
- Nations' Championship: 31st January to 7th February 2021

ARTICLE 3° ORGANIZATION

World Skate America will lead the organization of the event in administrative and logistical aspects and the Technical Committee of Artistic Skating the technical sports aspects.

ARTICLE 4° PARTICIPANTS-

Athletes from nations, leagues, clubs, associations that have the endorsement of their respective National Federation may participate in the competition.

ARTICLE 5° LIMIT OF REGISTRATIONS

- Clubs Event: Each club may register up to five (5) athletes per category, discipline, and gender.
- Nations Event: Each Federation may register up to three (3) athletes per category, discipline, and gender.

Coaches: For the club event, each club will have the right to register up to three (3) coaches plus one (1) delegate. In the nations event, each Federation may register up to five (5) coaches and two (2) delegates.

The accreditation of coaches and delegates registered for the club event will not be valid for the nations event.

ARTICLE 6º PENALTIES AND TEMPORARY INELIGIBILITIES

Any Club, Association, Confederation and/or Federation to register athletes, who do not show up for the event or who, while registered, do not show up for a particular event, will be sanctioned or disqualified as stipulated by the WSA.

The payment of the penalty is essential for the club/Federation to regain the right to participate in another competition.



PARAGRAPH 1º Athletes, clubs, Confederations and/or Federations will be exempt from the penalties described in article 6:

- Submitting an excuse accredited by an official doctor verified by the Federation to which they belong.
- For reasons of force majeure, duly verified by the WSA Artistic Skating Technical Committee and authorized by the WSA president.

PARAGRAPH 2º In the event that an organization or athlete is exempted from the established ineligibilities, it is not exonerated from the payment of the economic obligations acquired with the organization and the WSA, corresponding to the registrations of the athlete and/or club/Federation to the event, as the case may be.

PARAGRAPH 3° Athletes and/or clubs that engage in any of the ineligibilities described in this article, will have three (3) calendar days following the event, to present in writing the reasons they had to justify their non-attendance to the event, with the respective proofs to the e-mail inscripcionespanamericano@gmail.com.

ARTICLE 7º AWARDS

Prizes will be awarded to the athletes who occupy the first 3 places in each event, by gender and discipline. If the first three places are from the same country, the bronze medal will be given to the fourth place to avoid a complete podium from only one country.

ARTICLE 8º QUALIFYING PROCESS

This event will be a qualifier for the Junior Pan American Games Cali Valle 2021, which will have the women's and men's free skating events and a quota of eight (8) athletes in each event (Colombia, as host, has a fixed quota, but must participate).

It will qualify based on the results of the Senior category Championship. The first 7 countries in the Nations Championship in this category whose minimum age is 12 years and maximum 22 years until December 31, 2021 will be qualified to participate in this event.

The qualyfication is the athlete, not the country; in the case that an athlete qualifies and does not confirm participation in Cali Valle 2021, the quota will be given to the next country in the qualyfication that meets the conditions mentioned.

Since this is an atypical situation, the athlete who competes for a quota in the Games in the Senior category, but who is in a lower category, will be able to return to his original category in the following international events.



ARTICLE 9° DRAWS AND SKATING ORDER

For the figure competitions the draw will take place on the day of the technical meeting of each of the events. The skating order will be made with an electronic system and will be published in advance for review and correction prior to the technical meeting.

ARTICLE 10° RULE OF MUSICAL RHYTHM

At the time of registration, it will be mandatory to attach the certificates of authenticity of the music rhythm established for the Style Dance, issued by a music professional, with the letterhead of the organization to which the mentioned professional belongs. If this is not attached at the time of registration and when sent is outside the established date of registration, it will be charged as an extraordinary registration.

ARTICLE 11º REGISTRATIONS AND GUARANTEES

By disposition of World Skate America, the registrations of the clubs and nations **must be sent through the Federation and/or Confederation** to which they belong; registrations sent individually by each club or association will not be taken into account.

The registration must be sent according to the dates established in article 12 by e-mail inscripcionespanamericano@gmail.com.

The form published on the World Skate America website must be used, without converting it to PDF or image. Different formats will not be considered.

PARAGRAPH 1º The ORIGINAL form, duly signed by the club and Federation, must be submitted on the day of accreditation. Without this document, the accreditation cannot be done. Those registrations that are incomplete and presented in a different format will be considered as not having been received.

PARAGRAPH 2° It will be mandatory to attach at the time of registration the order of the technical elements in the nations event according to the format published in the World Skate web page.

PARAGRAPH 3° The music of the athletes MUST be delivered in a USB memory stick. Deliver one per club, association or country, will not be received USB per athlete. It must be recorded at 320 and in MP3 format. The name of each file must be: Name of the skater, surname of the skater, category_ Discipline_ Program.



PARAGRAPH 4° The club, association, or national team which is not represented at the briefing by its delegate duly accredited to the WSA will not be able to make any claims at the event.

ARTICLE 12º ENTRY FEES

The value of the ordinary and extraordinary registrations will be

PARAGRAPH 1º The value of the registrations to the Championship must be paid in cash in American dollars, by the respective delegate before the entrance to the briefing of the event (according to the detailed program to be published).

PARAGRAPH 2° For the athletes of a country to participate in the Pan American of clubs and nations Championship, independently of their individual, club or association participation, it is required that the Federation and/or Confederation to which they belong be in good standing for every concept with World Skate America.

ARTICLE 13º COMPLAINTS the rules of Word Skate will be followed.

ARTICLE 14° AUTHORITIES OF THE EVENT

- The highest authority is the Technical Direction of the event will be in charge of the person appointed by the President of World Skate America.
- The highest judging authority will be the judges/technical specialists.
- The maximum disciplinary authority will be the Disciplinary Commission of the event which will be composed of the judge-referee of the event, one of the delegates of the Pan American Commission attend, and a representative designated by the Host Federation of the event.
- The maximum Administrative authority will be the Management Committee of the event, at the head of the President of World Skate America.

ARTICLE 15º

Only the World Skate America Artistic Skating Technical Committee can modify or cancel a certain event that does not comply with the conditions of the competition, due to space on the stage, lack of time, lack of competitive level, guarantees, or unforeseen delays in the programming.



ARTICLE 16º TECHNICAL MEETING

There will be one for the club event and another for the nations event. The technical meeting of the event will be held at the place and time that the organization of the event arranges for that purpose and that will be announced in the official invitation. For this meeting, the presence of all the coaches registered in the respective forms and the judges who have been summoned is requested.

PARAGRAPH 1º Once the briefing is concluded, the judges' meeting will be held in the same room.

ARTICLE 17º LIABILITY IN ACCIDENTS

World Skate America and The Ecuadorian Skating Federation are not responsible for accidents that may occur during the event, which is why all skaters must have medical insurance and / or accident in force, ORIGINAL documents that must be submitted at the time of the respective accreditations.

ARTICLE 18º VALIDITY This resolution shall be valid from the date of its issue.
