

## RESOLUTION N° 010 September 2nd, 2021

By means of which the date, place and registration communicated according to articles 1° and 2° of Resolution No. 009 of June 20th, 2021 "For the holding of the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK HOCKEY CHAMPIONSHIP summoned in the city of Fort Pierce- Florida from the 16th to the 26th of September 2021" are modified.

The President of World Skate America, in use of his legal attributions, statutory and;

## **CONSIDERING**

That the World Skate guidelines provide that each Continental Area has the right and duty to organize Continental Championships in each discipline;

That according to the World Skate Statutes, each Continent has to be an extension of World Skate in the Geographic Area in question;

That the WSA 2020 calendar had foreseen the holding of the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK HOCKEY CHAMPIONSHIP, but because to the difficulties of the pandemic, it was determined with the USARS and the Organizing Committee of the event to postpone it and hold it in the second semester of the year 2021, so that the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK HOCKEY CHAMPIONSHIP, has been defined to be held in the city of Fort Pierce - Florida from the 16th to the 26th of September 2021.

That due to sanitary difficulties caused by the pandemic occasioned by Covid-19, the County of St. Lucie County through the Department of Health Emergencies, notified the director of the FENM CENTER, the non-use of the stage for all types of sporting and cultural events. This is because it will be used as an alternate hospital care center.

## **RESOLVES**

**ARTICLE 1º - ANNOUNCEMENT** — Convening the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK HOCKEY CHAMPIONSHIP, to be held in HALPATIOKEE Regional Park, located in Martin County 8303 SW Lost River Rd, Stuart, Fl. 34997 from 17<sup>th</sup> to the 20<sup>th</sup> of November 2021.



**ARTICLE 2º - REGISTRATION —** For the Nations event, each country may enter only one team in each of the categories and disciplines of the tournament.

Registration will be received ONLY on the WORLD SKATE AMERICA official form for Rink Hockey Championships. This form must be filled out completely (names, jersey numbers, date of birth, ID, or license number of each Federation) on a computer and should be sent via e-mail only by the Federations to <a href="mailto:cthp@wordlskateamerica.org">cthp@wordlskateamerica.org</a>.

ORDINARY Registration will be received until November 1<sup>st</sup>, 2021, and EXTRA-ORDINARY Registration until November 5<sup>th</sup>, 2021. The values and amounts for registration of Countries and Athletes are stipulated by WORLD SKATE AMERICA in its bulletin of fees as follows and always USD North American dollars:

The registration fee will be paid in cash per team in each category and discipline, at the facilities provided by WORLD SKATE AMERICA for the accreditation and technical meeting, which will be informed in due course.
