

RESOLUTION N° 001

June 20th 2022

For the purpose in which the **2022 PAN AMERICAN CHAMPIONSHIP OF ARTISTIC SKATING OF CLUBS AND NATIONS** is convened and regulated, to be held in the city of Cancun, Mexico, from September 1 to 11, 2022.

The president of the World Skate America and the chairman of the Technical Commission of Figure Skating, in use of their legal, statutory powers and;

CONSIDERING

- That the Pan American Calendar 2022 foresees the organization of the PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2022, in the city of Cancun, Mexico, from September 1st to 11th, 2022.
- That one of the duties of World Skate America is to regulate all the events of the official calendar for all the disciplines of skating.
- That this is the qualifier event for the Pan American Games Santiago 2023 which will have both the ladies and men categories for free skating events.
- That this is the qualifier event for the Central American and Caribbean games San Salvador 2023 which will have both ladies and men category for free skating and solo dance events.

DETERMINES

ARTICLE 1 CALL-

Summon and regulate how it is actually done, the 2022 PAN AMERICAN ARTISTIC SKATING CHAMPIONSHIP OF PROMOTIONAL CLUBS AND NATIONS.



PARAGRAPH 1 LEVELS AND CATEGORIES

- Club Championship, promotional level, tot, mini, espoirs, cadet, youth, junior and senior categories.
- Nations Championship, international level, tot, mini, espoir, cadets, youth, junior and senior categories.

PARAGRAPH 2 In clubs event, the competition will be held according to the technical regulations set in the World Skate America Artistic 2021 regulations, currently published on the website.

For Nations championship, world skate rules will apply.

PARAGRAPH 3 No athlete should compete in two different categories at events of the same kind (e.g. free ladies cadet and junior). At the promotional level, an athlete can compete at different levels (basic, intermediate, advanced) in different disciplines (e.g., Figures cadets basic, free cadets advanced).

PARAGRAPH 4: Athletes who participated in world championships in one category, cannot participate in a minor category in the Pan-American.

PARAGRAPH 4: Athletes of nations can participate in different categories as well.

ARTICLE 2 – DATES: Tentative dates (these dates could change according to the number of skaters in each event)

- Promotional Clubs Championship: September 1st to 5th, 2022.
- Show and Precision Championship: September 6th, 2022.
- Nations Championship: September 7th to 11th, 2022.

ARTICLE 3 - ORGANIZATION

World Skate America and Mexican Roller Sports Federation will oversee the event administrative and logistical aspects, and the WSA Artistic Technical Committee, the technical aspects.

ARTICLE 4 - PARTICIPANTS

In order to be eligible to participate, athletes from nations, leagues, clubs, associations need their National Federation authorization.



ARTICLE 5 - LIMIT OF REGISTRATIONS

Athletes

- Clubs Events: Each club may register up to seven (7) athletes per efficiency, category, discipline, and gender.
- Nations Event: Each Federation may register up to five (5) athletes per category, discipline, and gender.

Coaches

- For the clubs event, each club will have the right to register up to three (3) coaches andone (1) delegate.
- In the nations event, each Federation may register up to five (5) coaches and two
- delegates.

The registration for coaches and delegates for the club event will not be valid for the nations event.

PARAGRAPH. Accreditations of registered coaches and delegates for the amateur, clubs, promotional and nations events will be valid exclusively for the event in which they participate. The corresponding accreditation will be required for each event.

ARTICLE 6 - PENALTIES AND TEMPORARY INELIGIBILITIES

Any Club, Association, Confederation and/or Federation with registered athletes, that do not show up to the event or that, while registered, do not show up for a particular event, will be sanctioned or disqualified as stipulated by the WSA.

The penalty payment is mandatory to regain the right to participate in another competition.

PARAGRAPH 1. Athletes, clubs, Confederations and/or federations will be exempt from the sanctions described in article 7 if:

- Submit justification accredited by an official doctor verified by the Federation to which they belong.
- Present a positive Covid-19 test (PCR-RT) when traveling to the event.
- For reasons of force majeure duly verified by the WSA Figure Skating Technical Commission and authorized by the WSA President.



PARAGRAPH 2 In case that an organization or athlete is exempted from the established ineligibilities, it is not exonerated from the registration payment acquired with the organization and WSA, according to the registration of the athlete and/or club/federation to the event, as the case may be.

PARAGRAPH 3 Athletes and/or clubs that engage in any of the ineligibilities described in this article, will have three (3) days after the event, to present a written justification for their non-attendance, with the supporting documents to the e-mail inscripcionespanamericano@gmail.com.

ARTICLE 7 – AWARDS

For Clubs championship, medals will be awarded to the athletes who occupy the first four places in each event, by gender and discipline, as follows: 1 gold, 1 silver and 2 bronzes.

For Nations championship, medals will be awarded to the athletes who occupy the first three places in each event, by gender and discipline, as follows: 1 gold, 1 silver and 1 bronzes. If the first three places are skaters from the same country, the bronze medal will be given to the next place from a different country to avoid a single country podium.

ARTICLE 8 – QUALIFYING PROCESS

This event will serve as qualifier for the skaters to the Pan American Games Santiago 2023. 16 skaters will be qualified for this event as follows: 1 man and one lady from Chile that as a host country have a fixed quota but still have to participate. The other 14 skaters will be 7 men and 7 ladies from Pan American countries according to the following qualifying process:

In the nations championship, from junior and senior free skating events, ladies and men separately, a ranking will be made, based on the technical score of the participants from both categories together. The first seven countries, for ladies and men, will be the ones qualified to participate in the Pan-American Games.

In the case of the qualifying event for the Central American and Caribbean Games San Salvador 2023, the same format will used for classification but for free skating



and dance. The first nine countries will qualify to that tournament.

The qualification process will be by country.

PARAGRAPH. - The classification for both the Pan American Games Chile 2023 and the Central American and Caribbean Games El Salvador 2023 will NOT be nominal, these will be numerical by country.

ARTICLE 9 DRAWS AND STARTING ORDERS

For figure competitions, the draw will be held on the day of the briefing for each of the events. Starting orders will be made electronically and will be published in advance for review and correction prior to the briefing.

ARTICLE 10° MUSICAL RHYTHM RULE

At the time of registration, it will be mandatory to attach the certificates of authenticity of the rhythm of the music established for the Style Dance, issued by a music professional, with the letterhead of the organization to which the aforementioned professional belongs. If this is not attached at the time of registration and when it is sent it is outside the established registration date, it will be charged as an extraordinary registration.

ARTICLE 11 REGISTRATION AND GUARANTEES

By World Skate America disposition, the inscriptions of the clubs and nations must be sent through the Federation and/or Confederation to which they belong; Registrations sent individually by each club or association will not be taken into account.

The registration must be sent according to the dates established in article 12 by email inscripcionespanamericano@gmail.com.

The form published on the World Skate America page must be used, without converting to PDF or image. Different formats will not be taken into account.

PARAGRAPH 1. ORIGINAL form, signed by the club and Federation, must be submitted on the accreditation process. Without this document, this process cannot be finished. Those incomplete registrations presented in a different format will be considered as not received.

PARAGRAPH 2. It will be mandatory to attach at the registration process the set of elements sheet according to the format published in the World Skate web page for the promotional and nations event.

PARAGRAPH 3. Anything related to the music delivery will be addressed later. Deliver one per club, association, or country, will not be received USB per athlete. It must be recorded at 320bpm and in MP3 format. The file name format is as follows: Name of the skater, surname of the skater, category_Discipline_Program.

PARAGRAPH 4. The club, association or national team that is not represented at the information meeting, by its duly accredited delegate before the WSA, may not make claims at the event.

ARTICLE 12 – INSCRIPTION FEES

The cost for the ordinary and extraordinary registrations will be

PARAGRAPH 1. The value of the inscriptions to the Championship must be paid in cash in US dollars, by the respective delegate before entering the informative meeting of the event (according to the detailed schedule to be published).

PARAGRAPH 2. In order for athletes from a country to participate in the Pan American Championship of clubs and nations regardless of their individual, club or association participation, it is required that the Federation and/or Confederation to which they belong be in good standing. for all concepts with World Skate America.

ARTICLE 13 - COMPLAINTS

Word Skate rules will be followed.

ARTICLE 14 – AUTHORITIES OF THE EVENT

- World Skate Americas President will nominate the event manager.
- The highest judging authority will be the technical officials.
- The disciplinary committee will be comprised by the event referee, one of the Pan American Commission delegates, and a representative designated by the event Host Federation.
- The maximum administrative authority will be the World Skate America's President who will be the head for the Event Management Committee.

ARTICLE 15 – EVENT MODIFICATION OR CANCELLATION

Only the World Skate America Artistic Skating Technical Committee can modify or cancel a certainevent that does not comply with the competition conditions, due to rink space, lack of time, lack of competitive level, guarantees, or unforeseen delays in the programming.



ARTICLE 16 – TECHNICAL MEETING

There will be different brief meetings for each event. The event technical meeting will be held at the place and time that the event organization arranges for that purpose and will be announced later. The presence of, at least, one of each team coaches is requested for this meeting.

PARAGRAPH 1 Once the brief meeting ends, the judges' meeting will be held in the same room.

ARTICLE 17 LIABILITY IN ACCIDENTS

World Skate America and The Mexican Skating Federation are not responsible for accidents that may occur during the event. All athletes must have a medical insurance that must be presented at the registration process.

ARTICLE 18 VALIDITY

This resolution shall be valid from the date of its issue.
